

Advantages & Disadvantages of Critical Illness Cover



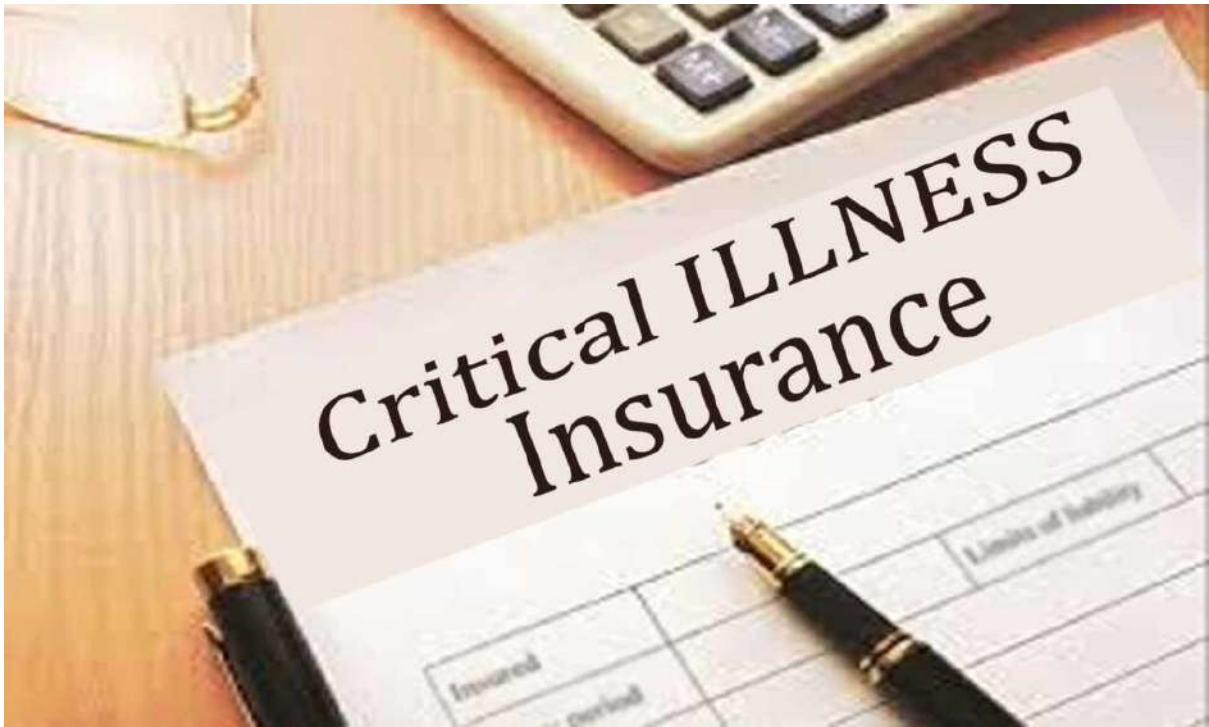
