The Tier 5 (Temporary Worker) visa is available for individuals coming to the UK to perform temporary work or participate in a government-approved exchange scheme. This visa is suitable for people working in creative or sporting industries, charity workers, religious workers, and those on the Youth Mobility Scheme. The visa is valid for up to two years (depending on the category) and cannot be extended.

#### #6 - Tier 5 (Youth Mobility Scheme) Visa:



The <u>Tier 5 Youth Mobility Scheme visa</u> is intended for individuals from specific countries, aged between 18 to 30 years old, who desire to reside and work in the UK for a maximum of two years. This visa is ideal for young people who want to experience life in the UK while gaining work experience. However, applicants must meet certain eligibility requirements, including passing an English language test, having enough money to support themselves, and not having any dependent children.

#### **#7** - Representative of an Overseas Business Visa:

The Representative of an Overseas Business visa is suitable for individuals employed by an overseas company and who need to establish a presence in the UK. This visa allows them to **stay in the UK** for up to three years and can be extended. Applicants must demonstrate that they are senior employees of the company. They have the authority to make decisions on behalf of the company, and plan to establish a branch or subsidiary in the UK.
